This past year has been a testament to the power of collaboration and the profound impact we can achieve together.


Children's Health Foundation remains steadfast in our mission to improve the health and well-being of children through innovative research, comprehensive care, and life-changing education and programs. This year, we deepened our commitment to advancing specialized areas of care, including neonatology, behavioral health, pediatric surgery, and research. Through your generosity, we have empowered our dedicated medical teams to pioneer new treatments and provide unparalleled care for children and their families.

This fiscal year has been marked by remarkable achievements. We hosted the inaugural Drew Neville Charity Classic at Oak Tree National, raising more than \$600,000, and the event was honored as the "Play Yellow Event of the Year" at the Play Yellow Invitational. We awarded \$2.2 million in grants to support critical initiatives, including pediatric clinical trials, cancer research labs, grant submissions, suicide research, obesity projects, neonatology labs, genetic research, facility renovations, and residency programs. Additionally, Children's Health Foundation awarded a \$76,000 grant to the Toby Keith Foundation's "OK Kids Korral," ensuring families receiving care at the Jimmy Everest Center for Cancer and Blood Disorders have a comforting place to stay. We also contributed \$125,000 to pediatric cancer trials led by Dr. Rene McNall, CHF Inasmuch Foundation Endowed Chair, driving vital advancements in the fight against childhood cancer. These accomplishments reflect our steadfast commitment to enhancing children's health and well-being.

In this annual report, we are thrilled to share updates on two remarkable individuals, Vivianne and Veronica, our 2023 Champion Children. Their stories embody the resilience and hope that drive our work forward. We extend heartfelt appreciation to our invaluable partners and donors whose generosity has enabled us to achieve meaningful milestones and transform the landscape of pediatric healthcare in Oklahoma.
